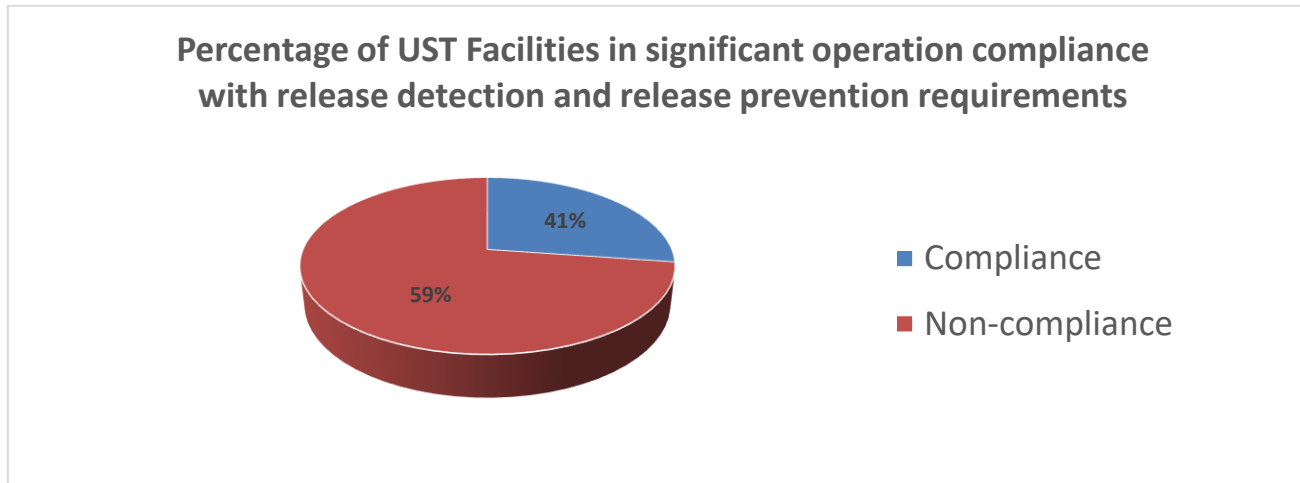

On-site inspections measure compliance with release detection and release prevention requirements with Subtitle I 40 CFR 280.12 and the Navajo Nation Storage Tank Act of 2012.
